1 Introduction

India is at the cusp of an e-mobility revolution. The Government of India is moving towards accelerated adoption of Electric Vehicles (EVs) by 2030 to cut down its carbon emissions. The state government is oriented towards building sustainable clean cities and create healthy ecosystems to de-congest transport lifeline in the state. NREDCAP is the State Nodal Agency for AP ICE Policy, 2024 in general and public and private charging stations.

2 Definitions

Any capitalized term, used but not defined in this Tender Document, shall have the meaning as prescribed to such term in the Agreement. 3.1. Tender Document download & Bid Processing Fees

- b) Prospective Bidders interested in participating in the Bid process are required to submit their Bids in response to this Tender Document along with a non-refundable Bid Processing Fee of Rs. 10,000/- plus 18% GST.
- c) Bidders shall provide the above non-refundable Bid Processing Fee in the e-procurement portal. Any Bidder will be eligible to participate in the Bid process only upon submission of Bid Processing Fee as per the timelines specified in Clause 3.2 of the Tender Document.

5. Project Scope

(NREDCAP), on behalf of NTPC, intends to select a supplier for the **Supply of 5 numbers of 3-Wheeler Electric Garbage Collection Autos at Puttaparthi, Sri Sathya Sai District**. The vehicles shall comply with standards and specifications of ARAI/ICAT/CIRT and applicable CMVR Rules.

Scope of Work includes:

- 1. Supply of Electric Garbage Collection Autos meeting all regulatory and statutory norms.
- 2. Provision of the following mandatory features:
 - o Wireless microphone set of reputed brand.
 - o Separate bins for wet and dry waste with rust-proof coating.
 - o Hydraulic lifting facility with button-type operation.
 - o OEM charger compatible with MoP/DISCOM/ARAI standards.
 - o NTPC branding sticker prominently displayed on each vehicle.
- 3. Training for drivers on operation, maintenance, and charging of Electric Autos.
- 4. Comprehensive insurance and warranty for vehicles and batteries for a minimum of 3 years covering all risks.
- 5. Completion of registration and provision of all relevant documents for road transport authority.
- 6. Delivery of user manuals and warranty/guarantee cards for vehicles and batteries.

Additional Conditions:

- The bidder must quote for all 5 Electric Garbage Collection Autos. Partial quotes will not be accepted.
- The bidder shall quote the rate inclusive of the 3.54% service charge (including GST) that NREDCAP will levy on the cost of E-Garbage Collection Autos.

- The bidder shall submit a Performance Guarantee /Bank Guarantee for a total amount of Rs. 1,50,000/- in favor of NREDCAP.
- Interested bidders fulfilling the eligibility criteria shall submit sealed bid documents containing Technical Bid documents and upload their scanned copies on the e-procurement portal, including Earnest Money Deposit (EMD) of Rs. 50,000/- (Rupees Fifty Thousand Only) and relevant processing fee.

- Important Note: Bidders have to give demonstration of 3-Wheeler Electric Garbage Collection Auto before submission of the bid. If the performance of the vehicle is found unsatisfactory, then their bid will be treated as non-responsive and Financial Bid will not be opened.

Bid Validity period and Extension of Proposal Validity period

The Bidder shall submit its Bid in response to Tender Document which shall remain valid up to Ninety (90) days from the Bid Deadline ("Bid Validity"). Authorized Representative reserves the right to reject Bid which does not meet the validity requirement.

In exceptional circumstances, prior to expiry of the original Proposal Validity Period, NREDCAP may request the Bidders to extend the period of validity for a specified additional period. The request and the Bidders' responses shall be made in writing. NREDCAP reserves the right to reject the Proposal submitted by any Bidder who fails to extend the period of validity of its Proposal in line with the provisions of this clause.

The Bid Validity Period of the Successful Bidder shall be automatically extended till the date on which the Agreement is signed and is in force.

5.1. Qualification Requirements

Evaluation of Bids will be based on meeting the Eligibility Criteria comprising of General Eligibility Criteria, Technical Eligibility Criteria and Financial Eligibility Criteria. Any Bidder who meets the Qualification Requirements stated herein shall be declared as "Qualified Bidder" for the purpose of evaluation under this Tender Document.

In addition to the above, the following mandatory requirements apply:

Important Note: Live Demonstration Requirement

Only bidders who successfully conduct a live demonstration of the proposed solution to NREDCAP's satisfaction will be considered eligible for further evaluation and bidding.

5.2. Eligibility Criteria

a) General eligibility criteria

- i. Covering Letter corresponding to Qualification Bid as per Format I of this Tender Document.
- Legible scanned copies of EMD and Bid Processing Fee shall be uploaded in accordance with this Tender Document and as per timelines specified in the Tender Document.
- iii. Certificate from designated labs for type and model approval of E- Garbage Collection Autos.
- iv. The OEM/Manufacturer/Dealer shall be registered with GST Authorities in Andhra Pradesh.
- v. The Electric 3- Wheeler Garbage Collection Autos with batteries shall be warranted for a minimum period of 3 Years from the date of delivery.

b) Technical Eligibility

i. Bidder must have prior experience in supplying electric vehicles to government organisations. Documentary proof of completion/ performance certificates from government organisations are mandatory.

c) Financial Eligibility

- i. Cumulative Turnover during last 3 years, FY 2022-23, FY 2023-24, FY 2024-25 shall be at least Rs. 50 Lakhs in the field of Energy Storage/ Electric Vehicles.
- ii. Copies of audited financial statements along with a certificate from Chartered Accountant/Statutory Auditor, as applicable, confirming the Cumulative Turnover. Audited financial statements shall be furnished. For Bidding Firms, copies of Income Tax returns with full details of turnover should be furnished along with a certificate from the CA confirming the Cumulative Annual Turnover and net worth.

5.3 Financial Bid

Cost per E- Garbage Collection Auto to run 100 kms per charge which includes 3 years of warranty, Registration charges, transportation, training to the drivers inclusive of all taxes, insurance for 3 years, transportation in Puttaparthi, Sri Sathya Sai District and any other charges /taxes, etc., as per the Format VI.

5.4 Earnest Money Deposit (EMD) and Performance Guarantee (PG)

a) **Earnest Money Deposit:** Earnest Money Deposit (EMD) shall be Rs. 50,000/- (Fifty Thousand) EMD shall be in the form of a Bank Guarantee in favour of "NREDCAP" payable at Tadepalli, Guntur district or a Bank Guarantee with a validity of 180 days as per the Format VII(a), shall be submitted by the Bidder along with the Bid, failing which the Bid shall be summarily rejected. The copy of the Bank Guarantee shall be uploaded in https://tender.apeprocurement.gov.in and the original Bank Guarantee shall be furnished to

- NREDCAP along with hard copies of the Tender Document, failing which the bid shall be summarily rejected.
- b) **Performance Guarantee (PG):** Upon issuance of the Letter of Award (LoA), the Successful Bidder shall be invited to execute the Agreement and shall furnish a Performance Guarantee of INR 1,50,000 (Rupees One Lakh Fifty Thousand only). The PG shall remain valid from the Effective Date and until the Expiry Date. The EMD submitted will be returned against the receipt of Performance Guarantee (Rs. 1,50,000/-).

- c) The OEM/Manufacturer/Dealer shall be responsible for submitting original invoice along with relevant documents to the NREDCAP office by Registered Post or by hand with necessary certifications from user organization and Project Director, NREDCAP, Sri Sathya

Sai District.

No separate reply/intimation will be given for the above, elsewhere.

5.7 Fraudulent and Corrupt Practices

- a) The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bid process and subsequent to the issue of the LoA. Notwithstanding anything to the contrary contained herein, or in the LoA, the Authorized Representative shall reject a Bid, withdraw the LoA, as the case may be, without being liable in any manner whatever to the Bidder, if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bid process.
