Sealed quotations are invited from the experienced Solar PV System Integrators for Design, Supply, Installation, Testing & commissioning with 5 years Comprehensive Maintenance (CMC) of 50 KWp (5 x 10 KWP) Grid connected Solar System and 10 KWp (5 X 2 KWp) off grid connected solar systems on roof top of 5 ashram and residential schools of Tribal Welfare Department of Andhra Pradesh. SCOPE OF WORK

- 1. Design, supply, installation, testing & commissioning of 5X10 KWp grid connected solar rooftop systems with net metering facility and 5X2 KWp off grid solar rooftop systems.
- 2. Five years Comprehensive Maintenance (CMC). The system integrator shall undertake the site visit once in every quarter apart from attending to the service calls by the user agency.
- 3. Arranging enhancement of contracted load wherever required as per the norms.
- 4. Arranging the bi-directional meter through DISCOM and arranging net metering facility along with mandatory protection equipments as per the guidelines of DISCOMs.
- 5. Arranging warranties/guarantees for various components of the solar pv system as per the guidelines of MNRE, Govt. of India.

ELIGIBILITY

The bidder shall fulfill all the following conditions:

- 1. Shall be one of the SPV supplier/manufacturers/system integrators registered with NREDCAP or empanelled suppliers in the category of 6 100 KWp for the year 2016-18, having validity up to 31.03.2018.
- 2. The system integrator shall have the experience of supply, installation, testing and commissioning and maintenance /after sale services in the field of grid/off grid

connected solar rooftop PV systems. The system integrator shall have experience of installation of at least 100 KWp solar grid connected systems and 25 KWp off grid solar rooftop systems in the State of Andhra Pradesh in the last three years period. The relevant experience certificate shall be submitted along with tender.

3. The bidder should have annual turnover of Rupees 2.00 Crore in any one of the last 3 financial years preceding the Bid Deadline subjected to the condition that the Bidder should at least have completed one financial year.

GENERAL CONDITIONS

- 1. All the components of solar PV systems shall be as per MNRE specifications.
- 2. Necessary MNRE Test certificates/IEC approval copies are to be enclosed along with the quote.
- 3. The financial bid shall be submitted separately for supply and installation & commissioning.
- The structures for installation of SPV modules shall be Hot Dipped Galvanized to withstand wind speed up to 150 KMPH. All the fasteners shall be of stainless steel only.
- 5. The 2 KWp off grid system shall consist of 2 KVA 48 V inverter with 48 V 300 AH low maintenance batteries of BIS standards.
- 6. The Off Grid system shall be designed and connected in such a way to meet the emergency loads of the school building.
- 7. The guidelines of DISCOMs for arranging net metering facility shall be followed. Wherever required the contracted load shall be enhanced as per the Net metering guidelines. Necessary documentary support will be extended by the school authorities.
- 8. The total SPV roof top systems along with net metering facility and also Solar Off Grid systems shall be completed in all respects in all schools within 30 days from the date of issue of work order.
- Tenderer shall submit the performance guarantee and warranty certificates for a period of 5 years for invertors and batteries and 25 years for solar PV modules as per MNRE guidelines.
- 10. The tenderer shall enclose demand draft for Rs.1,00,000 by way of demand draft drawn in favour of NREDCAP towards EMD. There will not be any exemption for

payment of EMD. The EMD of unsuccessful tenderers will be refunded after finalization of system integrator. The EMD of successful tenderer will be released only after execution of the project and after completion of one month successful operation of the system.

- 11. The bidder will be selected based on technical eligibility as per the tender conditions and total quoted price for on grid and off grid systems along with installation, commissioning and five years maintenance including taxes.

PAYMENT CONDITIONS

Payment will be released as detailed below:

- 70% of purchase order value will be released on installation, testing and commissioning of total system including net metering facility and handing over of the systems to Authorized representatives of Ashram/Residential schools concerned.
 The payment will be released after receipt of funds from Tribal Welfare Department.
- 20% will be paid after 30 days of successful performance and on receipt of funds towards eligible CFA from MNRE, New Delhi and on receipt of funds from Tribal Welfare Department.
- 3.
