## INTRODUCTION

The wind farm site is located at Kondameedapalli village, Kolimigundla Mandal, Nandyala District, Andhra Pradesh. Kondameedapalli is about 25 km from Tadipatri connected with a good tar road till Ankireddipalli 132 KV Substation. The existing NREDCAP wind farm is about 2.50 km from Ankireddipalli 132 KV Substation connected with wind farm road.

Under the MNRE demonstration scheme, NREDCAP has installed 0.50 MW (2x250 KW of **NEPC make**) Wind Power project on Tirumala Hills and the project was commissioned on 24.03.1995. For ease of Operation and Maintenance of Wind Turbine Generators (WTGs), WTGs were shifted to existing wind farm location of installed capacity of 2.25 MW (3x750 KW) at Kondameedapalli. The machines were in service till July 2023 and at present the machines are in stalled condition.

NREDCAP has 0.50 MW (2 x 250 kW) of NEPC Make M530 Model wind turbines at location 04 and 05, established under demonstration scheme of MNRE at Kondameedapalli village, Kolimigundla Mandal, Nandyala District.

The main purpose of tender is to invite the bidders for purchase of scrap of above said Wind Turbine Generators (WTGs) along with its all accessories on "AS IS WHERE IS BASIS " at Kondameedapalli wind farm site. The scope of work includes dismantling of windmills with its all accessories, loading and unloading and transportation of all material and clearing of site.

The Bidders are expected to submit their Bids proposing most economical solution. Before submission of Bids, they are advised to visit the wind farm location to make themselves fully conversant with the site conditions and available material at the site.

2. Price quoted should be inclusive of GST and duties and also payment towards 3<sup>rd</sup> party charges towards surveys, transportation charges, loading & unloading, if applicable etc.
3. The cost of any item / service, which is considered necessary for completion of the job, is deemed to have been included in the quoted price.

### **Cost of Bid document -**

Bid form fee of **Rs. 5000/- (Rupees Five Thousand Only)** + 18 % GST along with the bid should be paid online through respective portal in the software.

### **Earnest Money Deposit**

**Delivery -**

1. On receipt of full scrap value along with Security Deposit, the NREDCAP will issue Letter of Award (LoA) to the Contractor thereby enabling him to lift materials within the period specified in the work order.
2. Successful bidders should ensure that the material clearance is as per the seller's instructions. Neat and clean maintenance of the stockyard from where the material is lifted is the responsibility of the successful bidder. In such eventuality, however, the Contractor shall not be entitled to claim any compensation for such delay.
4. The scrap materials should be lifted completely without leaving anything on the ground.
5. Breaking/ cutting may be allowed to the extent necessary for facilitating loading into vehicles. Only safe oxy-acetylene gas cutting equipment will be allowed with permission of NREDCAP. The decision of the NREDCAP or his authorized representative shall be final in this regard.
6. The Contractor shall arrange for all tools and tackles, forklifts and hoists or cranes or labour at their own expenses, if required, only for the items against which loading is in Contractor's scope.
7. Vehicles shall be loaded as per their carrying capacities in compliance with the provisions of MV Act.
8. Once the goods / materials are taken out of the NREDCAP Wind Power project area, Contractor will be solely responsible for all sorts of claims like shortage, missing parts, damage, incident, accident, loss of material etc.
9. Contractor and his men are subject to the security rule of NREDCAP in force while in the NREDCAP WPP premises. The Contractor, their workmen agents or representatives shall not commit any nuisance, theft or indulge in any antisocial activities in the NREDCAP WPP premises and the Contractor shall be liable for the good conduct, safety & discipline of his workmen. In case of any such activity, delivery will be suspended and strict action as per law will be taken including forfeiture of Security Deposit.
10. While taking delivery of the material, the Contractor shall be responsible for any damage that may be done to the premises / fittings of the NREDCAP WPP in the course of removing the

scrap material purchased by them. The NREDCAP may, at its option arrange to make good such damages and the Contractor shall pay for the same on demand. If such payment is not made on demand, the NREDCAP may forfeit the Security Deposit or may stop delivery of the material till payment is made.

11. NREDCAP will not at any time be responsible for any injuries caused due to accident within its WPP site either to the Contractor or his representative / labour etc., and the buyer will make proper arrangements for any claim arising out of the employment under any statute. It is the responsibility of the buyer to provide necessary safety appliances (like hand gloves / safety shoes etc.,) to the labourers, who are engaged in loading the materials, if required.
12. If any accident or damage to the property / life etc. arises by reason of any act of negligence / omission / default or non-compliance with any of the Terms & Conditions or statutory regulations or rules and regulations applicable within the NREDCAP WPP site, on the part of the Contractor, resulting in death or injury to any persons or damages to the property of the NREDCAP, then in such an event the Contractor will have to pay compensation to such person including the employees of the NREDCAP for such accident or injury / death or damage caused to their employees or to any of the NREDCAP's employees or to others or to the NREDCAP's property. The Contractor shall in such event, keep the NREDCAP fully indemnified from any demand, claims or proceedings thereof.
13. Since the material needs to be transported from the existing windfarms of other developers, necessary care shall be taken during transportation and the contractor shall take utmost precaution and shall not disturb other projects.

#### **Contract period -**

The allocated work should be completed within the stipulated time period of **30 days** from the date of LoA.

#### **Penalties -**

The allocated work should be completed within the stipulated time period failing which Security Deposit will be forfeited. However, the VC&MD, NREDCAP may consider for extension of the time period considering valid reasons and based on the representation of the Contractor.

**Deduction:**

The TDS will be done as per the Govt. rules and regulations. The contractor shall issue necessary certificates of tax deduction.

**Insurance:**

You shall have to take insurance at your cost for man & scrap material to cover loss due to transit, theft, riots, damages, burglary, accidents & act of god etc. after finalisation of bid.

**Arbitration: -**

In the event of any dispute or difference arising out or touching upon any of the terms and conditions of this contract and / or in relation to the implementation or interpretation thereof, the same shall be resolved initially by mutual discussion and conciliation but in the event of failure thereof, the same shall be referred to the Hon'ble Court, Amaravathi. The decision of the arbitrator shall be final and binding upon the parties.

**Force Majeure:**

The obligation is subject to Force Majeure, which hereby declared to include all causes whatsoever beyond the control of successful bidder. Amongst such clauses but not exclusive of others are Act of God, War, Intervention of Government or Military Agencies, Vandalism, Landslides, Floods, Earthquakes, Pollution & Fires.

**Process to be confidential:**

Information relating to the receipt, examination, clarification and evaluation of proposals and recommendations for the award of a contract shall not be disclosed to the bidder or any other persons not officially concerned with this process, until the award of contract to the successful bidders has been announced. Any effort by a bidder to influence the NREDCAP, while processing of proposal or award decisions, may result in the rejection of proposal / bid.

## **SECTION VI: Instructions to Bidder -**

- 1) The tender shall be valid for at least six months from the date of finalization of tender and the bidder will be responsible for dismantling of windmills and its accessories and transportation of scrap material.
- 2) All materials shall be lifted at bidder cost and risk. Bidder shall take all safety & security measures during transportation of material.
- 3) Custody of scrap material - After finalization of the bid, the scrap material will be in the custody of bidder. They shall be responsible for any loss or damage to material on account of theft/accidental or any other reasons till lifting of material from NREDCAP site.
- 4) In case, selected bidder fail to execute dismantling of windmills and its accessories and transportation scrap material NREDCAP will have liberty to get the work executed from the second lowest bidder or eligible bidder without giving any notice, at the risk and cost of selected bidder. Any additional cost incurred by NREDCAP shall be recovered from selected bidder.
- 5) NREDCAP shall have access at any time to the works being carried out by bidder under the contract. All the work shall be carried out to the satisfaction of NREDCAP.
- 6) Please note that execution of said work at Wind Power Project, Kondameedapalli site are to be carried out by switching off the electric supply of the equipments and by observing all necessary safety precautions. Safety of personnel working on job is prime responsibility of the bidder and bidder must take accident insurance for them as state / central government norms.
- 7) The height of Wind Turbine Towers is around 30 m above the ground level. Hence, bidder shall take all necessary safety / life saving precautions during execution of work. Taking all safety and security measures along with insurance of work men at site shall be responsibility of bidder.
- 8) All tools' tackles plants and labours etc. which are required for dismantling of wind mills and its accessories are to be arranged by bidder at their risk & cost. NREDCAP shall not be held responsible for any accident to your persons during execution of work.

9) Termination of Contract: If the work is found to be not satisfactory and not as per the work order, NREDCAP reserves the right to terminate this contract at any stage by giving notice.

**10) Extension of the Contract:**

If the bidder desires an extension of the time on the ground of his having been unavoidably hindered in its execution of work or due to any other reason beyond his control, he shall apply to VC & MANAGING DIRECTOR NREDCAP, Tadepalli, 7 days prior to stipulated date of completion. The decision of the VC & MANAGING DIRECTOR NREDCAP, Tadepalli shall be final.

11) The work is to be executed according to the existing specifications of tender and accepted by Bidder.
